#### Introduction

Peavy for Governor 2026 is committed to protecting the privacy of every visitor to this website, every donor who contributes to this campaign, every volunteer who signs up to help, and every supporter who provides us with their contact information. This Privacy Policy explains what information we collect, how we use it, who we share it with, and what rights you have over your own information.

#### Information We Collect

We collect information you provide directly to us. This includes your name, email address, phone number, mailing address, and any other information you choose to submit when you fill out a contact form, sign up to volunteer, register for an event, or send us a message.

We collect donation information when you contribute through ActBlue or any other donation platform. This includes your name, address, employer, occupation, and payment information as required by California campaign finance law and federal election law. This information is also reported to the California Fair Political Practices Commission as required by law.

We collect information automatically when you visit this website. This includes your IP address, browser type, device type, pages visited, time spent on pages, and the website you came from. This information is collected through cookies and analytics tools including Google Analytics.

We may collect information about you from third party platforms including social media platforms when you interact with our campaign accounts on Facebook, Instagram, TikTok, Twitter, or YouTube.

#### How We Use Your Information

We use your information to communicate with you about the campaign, including sending updates, event invitations, volunteer opportunities, and fundraising requests.

We use your information to process donations and comply with campaign finance reporting requirements under California law and federal law.

We use your information to register you for events and confirm your attendance.

We use your information to improve our website and understand how visitors are using it through analytics.

We use your information to respond to your questions, requests, and feedback.

We do not use your information to sell you products or services unrelated to this campaign. We do not sell your personal information to any third party for commercial purposes.

### **How We Share Your Information**

We share your information with service providers who help us operate this campaign. This includes Wix as our website platform, ActBlue as our donation processing platform, Eventbrite as our event registration platform, and Google as our analytics provider. These providers are contractually required to protect your information and may only use it to provide services to us.

We share donor information with the California Fair Political Practices Commission and other government agencies as required by campaign finance law. This information becomes part of the public record as required by law.

We may share your information if required by law, court order, or government request.

We do not sell, rent, trade, or otherwise transfer your personal information to outside parties for marketing or commercial purposes.

### **Cookies and Tracking**

This website uses cookies and similar tracking technologies to improve your experience and collect analytics data. Cookies are small text files stored on your device that help us recognize returning visitors and understand how the site is being used.

We use Google Analytics to understand website traffic and user behavior. Google Analytics collects information anonymously and reports website trends without identifying individual visitors. You can opt out of Google Analytics by installing the Google Analytics opt-out browser add-on available at [tools.google.com/dlpage/gaoptout](https://tools.google.com/dlpage/gaoptout).

You can control cookies through your browser settings. Most browsers allow you to refuse cookies or alert you when cookies are being sent. If you disable cookies, some features of this website may not function properly.
