BAR 2 - CALIFORNIA CHARGE AT 18

On a Matter from When I Was 19 and young Years Old

There was a charge related to check fraud in California that occurred when I was approximately 18 years old. I want to address it directly.

Those charges were never completed. They were not commenced. They were dropped. There was no conviction. There was no sentence. There was no jail time.

I am not going to pretend that being 18 and making mistakes does not happen. It happens. What matters is what you do after. I built a life, a community, a campaign, and a platform for reform that is directly shaped by my understanding of how systems of poverty and desperation create the conditions that lead young people to make mistakes.

If someone tries to use this against me, I want you to know: I already told you. On my own website. Because that is what transparency actually looks like.

BAR 4 - CALIFORNIA MATTERS AND PEAVY V. HALEY

On California Legal Matters - And Why We Are in Court Right Now

There may be those who attempt to raise legal matters in California against my name. I want to be clear about what those matters actually represent.

Each and every time these accusations have been raised, they have been fictitious. Nefarious attempts by parties whose interest is in silencing a candidate who will not be silenced. The pattern is consistent: when a candidate from a community that has historically been targeted by systems of over-policing starts winning ground, those systems push back.

We are not running from that. We are fighting it in court.

I am currently a plaintiff in Peavy v. Haley, active litigation in which I am suing for the violation of my rights. I am not the defendant. I am the one who filed suit. I am the one demanding accountability. A candidate who is afraid of the law does not bring the law into court. A candidate who believes in justice does.

The case management conference is scheduled for May 19, 2026 at 2:00 PM. The case is active. We are fighting.

I am running for Governor to change a system that I have personally experienced using false accusations as a tool of suppression against people from communities like mine. The fact that I am still standing, still running, and still suing is exactly why I am qualified to reform it.

BAR 5 - THE MOVEMENT NEVER STOPPED

The Movement Did Not Stop. This Campaign Is Proof.

James Gildersleeve founded the Courageous Eight and invited Dr. Martin Luther King to Salem, Alabama. His father was murdered for the movement. The Gildersleeve family did not stop. They marched at Selma anyway.

Mose Wright pointed at killers in a Mississippi courtroom. His family did not stop.

My great aunt worked in the White House and was called a slur by the President of the United States. She did not leave. She kept serving.

I have faced fictitious accusations, legal attempts to silence me, and a political system not designed to include a woman who looks like me. I did not stop.

I filed suit. I organized. I gathered signatures. I built a team. I am running for Governor.

The movement James Gildersleeve built never stopped. The family of Malcolm X never stopped. The descendants of Shining Moon Star never stopped. John Conroy's promise was never abandoned.

WE ARE THE UNION STRONG. And we are still here.

BAR 6 - CLOSING STATEMENT

To the Voters of California

You deserve a governor who is honest with you. Not honest only about the things that make them look good. Honest about all of it.

I have been honest about all of it. It is right here on this page. You read it. You can make your own judgment.
